#### It's Time For Congress To **Enact Universal Health Care**

Former President Harry Truman first proposed universal health care for all Americans in 1948. Now, 61 years later, it's time for Congress to finally make it happen.

It's not just the moral imperative of providing quality health care coverage to approximately 47-million Americans currently without it; it's a fiscal imperative as well. The ever rising cost of health care in America is stifling economic growth. Even if it doesn't bother you that in America, the richest nation on earth, approximately 50-million people lack heath care coverage, you should at least be concerned that rising health care costs are seriously undermining business and individual prosperity.

Let's be clear, although millions of Americans lack specific health care coverage, that does not mean that they do not receive health care services when ill. Emergency rooms routinely see patients suffering nothing worse than a common cold. It's a system that's inefficient and very expensive.

And, despite the fact that they are still the party of 'no', Republicans nevertheless understand that we can no longer fail to address this problem. Indeed, if the eventual legislation is crafted well, you'll see, for the first time since President Obama took office, significant numbers of Republicans voting for it. It's not a question of congressional Republicans all of a sudden caring about the 47 or so million Americans who lack health care coverage; it's just that they see the writing on the wall.

While the vast majority of Americans do not want a single payer system (as in Canada), a vast majority of Americans do want health care reform and universal coverage. And therein lies the problem.

The Democrats hold majori-

ties in both houses of Congress and therefore will bring legislation to the House and Senate floors respectively for consideration. They (the Democrats) need to leave ideological considerations at the door. Whatever system they devise for covering all Americans, it needs to contain two basic elements: 1) Any citizen who currently has health insurance coverage and is satisfied with that health insurance coverage must be allowed to keep that health insurance coverage. 2) However they figure to pay for it, presently uncovered Americans should be offered the opportunity to pick a health care insurance policy of their choice. If Congress tries to impose a single payer system it will not fly.

The pressure on the political left is already building for a single payer system. The Democrats in Congress must resist. If the Democrats propose a single payer system, it will let the Republicans off the hook. If the majority party provides for universal coverage through private health insurance plans, health care reform will finally become a reality-and with substantial bipartisan support to boot.

The Woodside Herald believes that now is the time to get it done.

## **Governor Appoints Sunnyside Attorney To Commuter Council**

The Long Island Railroad's watchdog group is going through some significant changes, including the appointment of a new chairperson and new representative on the MTA board. The LIRR Commuter Council officially name Maureen Michaels as its new

chairwoman, replacing Gerard Bringmann, who had held the post for four years.

Gov. David A. Paterson has appointed attorney Ira Greenberg, of "Sunnyside (Queens, New York)", as the commuter council's non-voting representative on the MTA

board. Ira has been a member of the council since 2005, he frequently commutes from the Woodside station, said he hopes to be "a voice for all of "Long Island" and to push for greater recognition of the LIRR's Queens and Brooklyn riders and reverse commuters.

### **Crowley-Serrano PCB Cleanup Initiative for Schools Approved by House**

National Green Schools Act passed by U.S. House of Representatives today includes provision to help school districts fund PCB cleanup

(Washington, DC) – Today, Congressmen Joseph Crowley (D-Bronx, Queens) and José Serrano (D-Bronx) applauded passage of the 21st Century

Green High-Performing Public Schools Facilities Act (H.R. 2187) that included a provision written by Crowley-Serrano to help school districts fund cleanup of polychlorinated biphenyl (PCB) contamination in New York City and throughout the

country. This initiative will provide schools with access to funding for critical modernization, renovation and repair projects. "We have a responsibility

to ensure that our children are taught in a healthy school environment," said Congressman Crowley. "Like asbestos and lead paint, the presence of PCBs in school classrooms is unacceptable. That is why I teamed up with my good friend Joe Serrano to raise awareness in Congress of this dangerous contaminant and to include the cleanup of PCBs in broader legislation that will keep our schools safe for our children. A problem this serious demands that the federal government provide some help to state and local governments, and I applaud the House for approving this important provision as part of the Green Schools Act."

"PCB contamination in our schools is intolerable—and I am glad Congress is acting to do something about it," said Congressman Serrano. "Since Joe Crowley and I heard about this problem, we've been working toward a solution, because the place where our children spend their days must be safe. No parent would tolerate a hazardous substance in a child's bed-

#### Five-Borough Economic Opportunity Plan Getting New Yorkers Through Tough Times

Even in these hard times, most New Yorkers are going to keep their jobs and keep their homes. But there are also thousands of people who are in trouble. Some have recently been laid off. Others are facing foreclosure. Some who own businesses are struggling to keep their doors open. Others are drowning in debt.

This recession is making it hard for businesses and households alike to make ends meet. But we want you to know that help is available. We're implementing a wide range of initiatives that offer



help to New Yorkers during these tough times. They're all part of our Five-Borough Economic Opportunity Plan – which is our comprehensive strategy for guiding New York City through the economic downturn as quickly as possible.

Let me first talk about what we can do for people in the job market. In tough times like these, it's easy for job-hunters to feel dejected – but putting as many New Yorkers as possible to work is essential to our recovery. Before you get dis-

couraged, visit one of our Workforce 1 Career Centers, which have developed close relationships with the industries that are hiring. In just a few short years, these Centers have gone from placing 500 people in jobs per year... to placing more than 17,000 per year. # LEGISLATION TO PROVIDE 13 WEEKS OF EXTENDED UNEMPLOYMENT BENEFITS FOR JOBLESS NEW YORKERS

State Senator George Onorato (D-Queens), the chairman of the Senate Labor Committee, announced that legislation (S.4110-A) he sponsors to permit New York to receive more than \$600 million in federal stimulus funds for unemployment benefits and administration has been approved by the Senate Finance Committee. As part of this legislation, an additional 13 weeks of extended benefits will be provided to jobless New Yorkers already receiving aid, and funding will also be provided to support benefits for newly unemployed workers.

The legislation, which was passed by the Senate Labor Committee on April 20th, is now expected to head to the Senate floor for a vote by the full house after unanimously passing the Finance

Committee yesterday. The funding is being made available as part of the American Recovery and Reinvestment Act of 2009 (ARRA).

"I could not be more pleased that this vital legislation, which will provide an additional 13 weeks of unemployment benefits for New York's jobless, is now moving swiftly towards becoming law," said Senator Onorato. "Unemployment benefits for some 56,000 jobless New York residents are slated to begin running out next week, with at least 5,000 more a week after that. Passage of this legislation will provide unemployed New Yorkers with critically needed financial assistance during very difficult economic times. This is a win-win for unemployed workers in need of aid, as well as for local economies that will benefit from the money these New Yorkers will spend on food, rent and other basic needs in their communities." All told, the extended benefits will ultimately aid some 120,000 unemployed workers now receiving assistance.

The legislation, initially proposed by Governor Paterson as a program bill, is expected to be considered today by the Assembly Committee on

Labor. The 13 weeks of extended unemployment benefits funded under this bill would be in addition to 33 weeks earlier approved by the United States

Congress and the 26 weeks of regular jobless assistance provided under New York state law.

Under the legislation, several hundred million dollars in federal stimulus funding will also be used to help stabilize New York's **Unemployment Insurance Trust** Fund, which pays out benefits for unemployed workers. In light of the growing numbers of jobless residents in New York, the Trust Fund has become insolvent. To qualify for this Trust Fund support, New York needed to conform its state unemployment law to ARRA language for individuals who must leave their jobs for compelling family reasons, including domestic violence and the illness or disability of an immediate family member. All of these compelling reasons have long been recognized under New York State case law and statutes, and the legislation will not create new grounds for benefit eligibility in New York.

This legislation will ultimately provide truly critical relief for

120,000 job-seeking New Yorkers who are now in imminent danger of losing unemployment benefits that they need to stay afloat and off of the public assistance rolls," said Senator Onorato. "I am greatly anticipating its final passage by the Legislature and immediate approval by Governor Paterson."

# Assemblywomen Catherine Nolan: MTA Agreement Prevents Sky-High Fare Hikes, Eliminates Service Cuts

Assemblywomen Catherine Nolan (D-Queens) announced an agreement to bail out the financially strapped Metropolitan Transportation Authority (A.8180). The agreement will put an end to the MTA's proposed sky-high fare hikes and severe service eliminations and cuts, and institute reforms of how the authority operates.

"The agreement provides \$60 million to reimburse public school districts for the payroll tax within the same school year - helping to reduce the burden on property taxpayers," Assemblywomen Nolan said. "This is a major victory for commuters and our regional economy. The MTA's plan to eliminate subway and bus lines, drastically scale back services and impose exorbitant fare hikes would have been devastating in this economy. This bailout plan is New York's best hope to save the transit system, save the fare and keep subways and buses running for the long haul."

Assemblywomen Nolan said the agreement prevents a 32 percent increase in fares and tolls that would have gone into effect within weeks. Instead, commuters can expect a greatly reduced 10 percent increase in fares. The agreement also funds two years of capital projects, including transit and commuter rail maintenance and modernization projects.

Additionally, there will be no

new tolls on bridges that are currently not tolled, Assemblywomen Nolan said. There will be no cuts in service, reversing the MTA's plan to eliminate 21 local bus routes and the complete elimination of two subway lines.

"We could not allow New York's transit system to crumble because of the MTA's budget crisis," Assemblywomen Nolan said. "It was essential that the bailout plan include funding for maintenance and upgrades to tracks, signals and equipment. The future of our transit system can't be compromised."

Assemblywomen Nolan said the agreement also includes long-overdue reforms of the MTA, giving the Legislature the authority to conduct independent audits every two years beginning in 2009, combine the positions of chairman and chief executive officer, create a new mission statement, and appoint board members who have an expertise in finance or transportation.

"This agreement will require an overhaul of how the MTA operates - gone are the days when board members are appointed regardless of their expertise," Assemblywomen Nolan said. "We must institute a process that demands transparency and long-term fiscal responsibility from the MTA to ensure taxpayers do not continue to pay for its financial mismanagement."

Other provisions include vendor preferences for owners who are

state residents and programs to encourage minority-owned businesses within the transit system.

Everyone is struggling to balance their budgets, Assemblywomen Nolan said. We needed to ensure that the burden to make our transit system whole was shared by everyone, not simply commuters. The compromise protects services and limits fare increases by instituting:

\* an employer-paid payroll tax in the 12 counties served by the MTA;

\* a 50-cent surcharge on taxi rides;

\* a \$25 increase in vehicleregistration fees;

\* a 5 percent increase in the auto-rental tax;

\* an estimated 25 percent increase in driver license fees; and

\* delayed future increases - fares and tolls will rise again by 7.5 percent in both 2011 and 2013.

"Solving the immediate crisis and providing funding for future projects - without massive fare increases or service cuts - will ensure New York's transit system keeps rolling," Assemblywomen Nolan said.

room, and similarly, no school or government should tolerate them either. Joe and I are committed to resolving this problem."

The 21st Century Green High-Performing Public Schools Facilities Act (H.R. 2187) provides critical funding to states and school districts to help ensure that school facilities and learning environments are safe, healthy, energy-efficient, environmentally friendly, and technologically advanced; the Crowley-Serrano provision makes grants and low-interest loans available to local educational agencies for the removal, abatement, or interim controls of PCBs during the construction, modernization or repair of public schools. The Act passed the U.S. House of Representatives today by a vote of 275-155, and now goes to the Senate for consideration.

Congressman Crowley is a Member of the House Ways and Means Committee; Congressman José Serrano chairs the House Appropriations Subcommittee on Financial Services and General Government.

According to the May 2009 issue of VFW Magazine "The Obama Administration in February offered a 15% increase in funding for VA in 2010. The \$112.8 billion proposed budget includes \$55.9 billion in discretionary spending for next year, an increase of \$5.5 billion from

"This outline in consistent wit recommendations made by the veterans groups who co-author the Independent Budget (IB)," said Rep. Bob Filner (D-Calif.), chairman of the House VA Committee. "This has never happened in the 23-years history of the IB."

VFW, one of the IB co-authors, is pleased with the proposal, Highlights include:

\* A "concurrent receipt" provision (and perennial VFW objective) that for the first time would allow military retirees to keep their full VA disability compensation and all their retired

\*Additional funding that would allow more than 500,000 veterans to enroll in VA's health care system by 2013.

\*Provisions that would expand VA mental health screening and treatment for veterans in rural areas through an increase in the number of Vet Centers and mobile health clinics."

This is a tremendous reversal from the President's original plan to make veterans pay for VA treatment, and I personally commend him for correcting his position. However in order for the President's new proposal to become reality we all need to write our elected officials and let them know we expect bipartisan support of this proposed budget. ## LaGuardia Community College Student **Elected International President of** Phi Theta Kappa Honor Society

Edgar Romero, a La Guardia Community College honor student who has distinguished himself as an exemplary student leader and public service advocate, has been elected to the ultimate leadership post: international president of the Phi Theta Kappa Honor Society of the Community College.

Serving as the 2009-10 president of the largest honor society in the country, with 2 million members and 1,250 chapters, is considered the pinnacle of leadership within the organization. During his one term in office, Edgar will be responsible for presiding at the International Convention and Honors Institute, making International Convention committee appointments, signing all new chapter charters and representing PTK at regional meetings and educational conferences.

"This is the best thing that can happen to any community college student who wants to take a leadership position and serve his or her community," says the international studies major. "As president, I'll be involved in the same missions that I want to carry out in my life: working on international projects as a member of a non-governmental organization."

"Edgar is that rare student who not only is interested in getting the most out of his college experience but is committed to giving back to the institution," says LaGuardia President Gail O. Mellow. "As a member and officer of the College's PTK chapter, he developed and organized programs that have made a difference for our students. I am confident that he will bring to the presidency the same energy, creativity and vision."

For the Venezuelan émigré who enrolled in LaGuardia in 2007, it was at the College that he discovered his passion for community service, and was given the opportunity to develop his leadership skills. "Before I came to LaGuardia, there were many times I would view a documentary or read an article and say to myself, 'what can I do?' but that was as far as it would go," he says. "It was at LaGuardia that I decided to challenge my excuses."

The turn-around came when he attended a leadership program workshop during his first semester. "The key message the workshop leaders passed along to the students was, 'the first thing you should do is get involved," "he says.

Heeding the message, he joined the United Nations Club, and volunteered at the College's Alpha Theta Phi chapter of PTK because he did not have the minimum credit requirements to become a member.

As a volunteer, one of his major achievements was finding a way to pay for the shipment of refurbished school supplies that the chapter had collected for an impoverished school in Ecuador. 'The members learned that the shipment would cost \$2,000 and didn't know how to secure funds," says Edgar, "so I made phone calls to consulates, embassies and missions in the U.N., and eventually found a company willing to subsidize the shipping costs to Ecuador."

"His efforts amounted to nothing less than 'a beautiful miracle,' " says Professor Karlyn Koh, who is the chapter's faculty advisor.

Edgar also planned a forum on women in Afghanistan in conjunction with Women for Afghan Women (WAW), a nonprofit organization that aids Afghan refugee women. Events included a documentary and discussion on the struggles of American and Afghan widows in their fight for women's rights in the Middle East, and a lecture on the role Afghan women play in the development of their na-

"Both events, completely coordinated by Edgar, were well organized, well attended and well received, thanks to his efforts," says Professor Edward Goodman. "He planned with members of WAW, recruited student volunteers to assist, and he says, "that can have a tremet with faculty from across mendous impact."

the College to ensure that classes were brought to the events."

A summer camp also grew out of his relationship with WAW. Edgar conceived of the idea, developed the program and recruited LaGuardia students for counselor positions. The children of the women who attended the center spent eight weeks playing soccer and basketball and going on field trips to the Bronx Zoo and the Museum of Natural History.

"Edgar and his friends transferred not only their love for the game to these kids but their standards of behavior as well," Mahshad Mohit, the program manager, said in a thank-you letter. "They taught them fellowship and teamwork, a sense of responsibility and importance of a clean environment."

For another forum, Edgar invited the Venezuelan consul general who spoke on the impact of wealth distribution in her country.

He officially became of member of the honors society in December of 2008; and one month later was elected vice president of programs and events. The honor society recognized his hard work recently by awarding him PTK's 2009 Distinguished Chapter Member.

While he spends countless hours working on chapter projects, Edgar still manages to maintain a 3.61 grade point average and to work part-time as a manager at a Manhattan restaurant.

But if you'd like to see a somewhat different outcome in 2008, you may want to review all areas of your tax return, including your investment-related taxes. As you may know, some investments are more "tax-friendly" than others are - and municipal bonds might be some of the friendliest ones of all.

If you aren't that familiar with municipal bonds, here are the basics: Municipal bonds, or "munis," are issued in two main categories: general obligation bonds and revenue bonds. General obligation bonds finance the activities of state and local governments, while revenue bonds pay for specific projects, such as airports, hospitals and other civic institutions.

So, when you purchase a muni, you're supporting a project or service, possibly in your state or community. And you will be rewarded for your civic-mindedness - through tax breaks. Specifically, your interest payments will be free from federal taxes; if the municipality that issues the bond is in your state, your interest

from state and local taxes.

Municipal bond interest is free from federal taxes, but some munis — particularly airport and housing bonds might be subject to the alternative minimum tax (AMT). If you think you may have to pay the AMT - and a lot more people are subject to this tax now than in years past - you might want to avoid these types of bonds. Conversely, if you know you won't be assessed the AMT even if you bought some AMT-subject munis, you might be especially interested in these bonds, because their yields are typically higher than the yields on regular municipal bonds.

In any case, municipal bonds offer some benefits bevond tax-free interest. For one thing, munis can help you diversify a portfolio heavily weighted with stocks. Municipal bonds may not be affected by many of the factors - such as poor corporate earnings reports - that cause volatility in the price of stocks. So, municipal bond prices generally do not move together with stock prices.

Furthermore, municipal bonds are among the most secure investments you can

payments also may be exempt own. The default rate on munis - especially general obligation bonds - is typically quite low.

Which types of municipal bonds are right for you? Your choice depends, to a great extent, on your goals and investment personality. For example, longer-term munis - those bonds that mature in 10 years or more - will generally pay a higher interest rate than shorter-term bonds. Yet, prices of the longer-term offerings also may fluctuate more.

You may want to consider owning a variety of short-, intermediate- and long-term munis. This type of portfolio known as a bond "ladder" can help you in all types of interest-rate environments. When market rates are down, you'll benefit by owning longterm bonds, which generally pay higher rates than shortterm bonds. But if market rates are up, you can use the proceeds of your maturing shortterm bonds to reinvest in issues with higher rates.

Finally, when you're shopping for municipal bonds, look for quality - those bonds that are rated at least "A" or higher by the major rating agencies.

Municipal bonds occupy their own special niche in the investment world - and it's a niche that you may want to explore further.



# YOUR EYES

## Why Early Eye Exam?

Young children are vulnerable to many of the same optical defects and eye disorders that adults are. These and other conditions that generally first show up in early childhood present a particular problem, since it is during that time that children learn to see. All children should have had their first eye examination by three years of age.

The two main components of normal vision are 20/20 eyesight and the ability to use the two eyes together (binocular vision). Nature has provided the first six years of life for learning these two skills. After six, or so, it is usually more difficult for a child to pick them up. Any interference with this learning process, such as an optical defect, can seriously and permanently impair the development of normal vision. That is why it is so vital to correct eye problems in children as early as possible. Early examination of your child's eyes is, therefore, a major parental responsibility.

#### **Corn and Pork Skewers**

3 ears fresh super sweet corn, husked

2 small zucchini 2 small sweet red bell peppers

1/4 cup olive oil

2 tablespoons lemon juice 4 teaspoons oregano

2 teaspoons chopped garlic

1 teaspoon salt 1/2 teaspoon ground black pepper



Preheat grill or broiler. With a large, sharp knife, cut corn in 2inch pieces and the pork, zucchini and bell peppers in 1-inch pieces. In a large bowl, combine oil, lemon juice, oregano, garlic, salt and pepper. Add pork and vegetables; toss to coat. Let stand for 10 minutes at room temperature. On eight (10- to 12-inch) metal skewers, loosely thread pork and vegetables. Grill or broil, turning occasionally, until meat is cooked through, eight to 10 minutes. If desired, serve with salad greens. Pork and vegetables can also be cooked "unskewered" on a grill rack or broiler pan, for eight to 10 minutes, turning often. Serves four


