## QUEENS D. A. RICHARD A. BROWN BEGINS 19TH YEAR AS BOROUGH'S TOP LAW ENFORCEMENT OFFICIAL

### Was Sworn Into Office 19 Years Ago Today

District Attorney Richard A. Brown of Queens County today begins his 19th year as the borough's top law enforcement official. He was sworn into office on June 1, 1991 - 19 years ago today - following his appointment by then Governor Mario M. Cuomo. He was thereafter elected to a full four-year term that November and has been re-elected every four years since.

District Attorney Brown said, "It has been both a pleasure and a highlight of my almost 50 year career in public service to serve as the District Attorney for Queens County. Over nearly two decades we have developed into one of the most respected offices in the country by focusing on training and innovations that have raised the level of both our professionalism and aggressiveness."

District Attorney Brown added, "Despite the economic pressures and a caseload on track to reach 80,000 cases this year (up from 72,000 in 2008), we are confident that we will be able to maintain significant reductions in crime that have been seen in Queens County over the last 18 years."

The District Attorney has continuously been at the forefront of creating innovative programs that enable his staff to zero in on cases and fight for justice more effectively. Among the most successful are the development of a Child Advocacy Center for young victims of sex crimes; a Family Justice Center for victims of domestic violence; the office's Sec-

ond Chance Program for first-time, non-violent criminal offenders; the STAR (Straight Talk About Risks) Track Program focusing on steering young people in Far Rockaway to stay clear of violence; and a pre-arraignment interrogation programs in which defendant statements are videotaped to support filed charges or free the innocent.

District Attorney Brown has also long served as the Chair of the New York Prosecutors Training Institute, which provides continuing legal education to prosecutors across the state and is committed to continuing to raise the level of professionalism among his own prosecutors as well.

In addition, the District Attorney has overseen some of New York's most notorious cases over the years, including last year's Sean Bell police shooting investigation and trial and massacres at a Wendy's in Flushing and a College Point apartment. The District Attorney's office also annually handles more wiretaps than any other office in the country except for Los Angeles and is a leader in long-term investigations into such criminal activity as identity theft, mortgage fraud, credit card fraud, narcotics trafficking, auto theft and organized crime.

District Attorney Brown was born in Brooklyn and raised in Queens. He received his Bachelor of Arts degree from Hobart College in 1953, graduated from New York University School of Law in June 1956 and was admitted to the Bar by

the Appellate Division, Second Department in October 1956.

Prior to becoming a member of the judiciary in September 1973, Judge Brown spent nine years serving in various important legal positions on behalf of the leadership of the New York State Senate and Assembly and at the 1967 New York State Constitutional Convention and four years as New York City's Legislative Representative in Albany where he managed the City's Albany office and supervised its legislative program.

After serving as a Judge of the Criminal Court for less than two years, Judge Brown was appointed as Supervising Judge of the Brooklyn Criminal Court and assumed full administrative responsibility for the operation of that court and supervision of all judicial and non-judicial personnel. In January 1976, Judge Brown was designated as an Acting Justice of the Supreme Court of the State of New York.

In November 1977, Judge Brown was elected a Justice of the Supreme Court in Queens County. At the end of the following year he returned to Albany as Counsel to Governor Hugh L. Carey where he served as the Governor's chief legal advisor. On March 3, 1981, Judge Brown returned to the Supreme Court and the following year was designated by Governor Carey as an Associate Justice of the Appellate Division, Second Department. He was thereafter twice re-designated as a member of the

## Grand Old Party Republican Club Welcomes Candidates

Mr. Maragos, who is running for the seat of Councilman Eric Gioia, who is leaving due to term limits, said that it is time for change and that he will represent all the people in the 26th Council District.

Mr. Zablocki, who is running against Councilman Gioia for the office of Public Advocate, said that, if elected, he will fight for accountability in government, less traffic and better mass transit, safer streets, economic development and the middle class. He has been endorsed by the five NYC Republican committees.

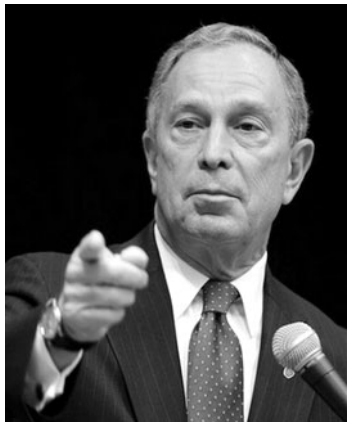

## Sign Up for Notify NYC

Have you ever wished that you could find out about unexpected events affecting your community as soon as they happen? Things like natural disasters, fires, unplanned school closings, or last-minute changes to parking rules? Information that's clear, quick, and accurate instead of the sometimes misleading or incomplete accounts that swirl around an emergency? Well, now you can.

Last month, we rolled out a new, citywide alert system called Notify NYC. It's going to revolutionize the way City government communicates important information to the public by using the technology that people already have at their fingertips:



cell phones, Blackberries, and PDAs. Notify NYC allows us to send real-time, neighborhood-specific alerts to those devices by e-mail, text message, and automated telephone calls.

Here's how it works: New Yorkers who want to receive alerts should log on to the City's website, [www.nyc.gov](http://www.nyc.gov) <<http://www.nyc.gov/>> and enter their contact information - which will be kept confidential and used only for Notify NYC purposes.

Each Notify NYC subscriber will automatically receive alerts about major emergencies and natural disasters - as well as time-sensitive information that depends on an immediate response, like 'Amber Alerts' for missing children. Subscribers also have the option of signing up for notifications of less-severe events, such as public safety exercises by our Police and Fire Departments or disruptions to water, electricity, and telecommunications services.

What's more: Subscribers can sign up to receive alerts for up to five different zip codes. That means you might register for information for the neighborhoods where you live and where you work and also, for example, the areas where your kids go to school.

Some New Yorkers are already familiar with Notify NYC because in 2007, we launched a limited trial of the system in four neighborhoods. Since that time, we have sent out more than 70 advisories to more than 12,000 subscribers about a range of incidents and emergencies.

Now, as we roll out the system citywide, we're also creating a new unit within the City's Office of Emergency Management dedicated to emergency communications with the public. The unit will be staffed 24 hours a day, 7 days a week - and it will be responsible for sending Notify NYC messages and making sure that Notify NYC information is also posted on the City's website and distributed to 311 and 911 operators to ensure that the information the City gives out is accurate and consistent.

Having taken office just 3 months after 9/11, our Administration has always been aware of how important it is to get

clear, accurate, and timely information out to the public. That's especially true in an emergency situation. Many of the nation's largest cities are in the process of developing

emergency alert systems. But Notify NYC is by far the most comprehensive and technologically advanced - and it surpasses all others in its depth of planning. I encour-

age all New Yorkers to visit [www.nyc.gov](http://www.nyc.gov) and sign up for Notify NYC. It will give you information when you need it - and peace of mind when it's most important.

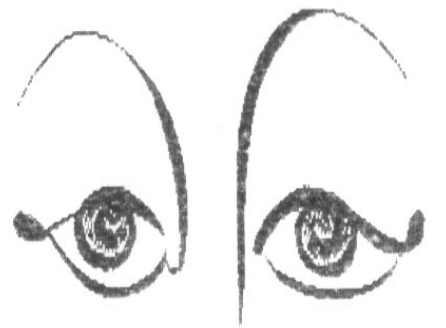

## Wallace Post Veterans Gather To Remember Our Fallen Heroes

The members of the John E. Wallace Post #1630 American Legion gathered over the Memorial Day weekend to honor America's fallen soldiers and the members of the Post who have passed on. The Post is named after a local sailor who perished, with the five Sullivan brothers and hundreds of other sailors, when their cruiser, the USS Juneau, was torpedoed by a Japanese submarine, off Savo Island, in 1943.

Led by the Post Commander, Robert Clark, they gathered at the Sgt. Daniel Kish Square, which is near the Post, in Long Island City. Sgt. Kish was a soldier who was killed on Okinawa, in April 1945. The members placed a wreath on the flagpole. A second wreath donated by the members of the John V. Daniels Jr. Post 2813 Veterans of Foreign Wars was also placed on the flagpole. The acting Chaplain, read a prayer for the fallen and the members, and guests, rendered the final salute.

### Public Information Meetings for Waste Management of New York, LLC Review Avenue Solid Waste Transfer Station Part 360 Permit Modification Application

Waste Management of New York, LLC (WM) has made an application to the New York State Department of Environmental Conservation (NYSDEC) to modify its existing Part 360 Permit to operate a solid waste transfer station at 38-22 Review Avenue in Long Island City. WM is proposing to replace the existing truck-based transfer operation at Review Avenue with a new, rail-based solid waste transfer facility, which would receive residential waste from Western Queens under a long-term agreement with the NYC Department of Sanitation (DSNY). Within the fully enclosed facility, waste would be tipped by DSNY collection trucks and then would be placed in intermodal containers. These containers would be sealed and transferred by truck to the Maspeth Railyard, for shipment by rail to disposal sites out of the City. To implement this plan, WM seeks to increase the permitted capacity of the Review Avenue solid waste transfer facility from 958 tons per day to 2,100 tons per day.

The subject proposal is currently being reviewed by the NYSDEC for conformance with the State Solid Waste Management Facilities regulation (6 NYCRR Part 360) and to determine, pursuant to the State Environmental Quality Review regulation (6 NYCRR Part 617), if the subject proposal will result in a potential, significant, adverse impact, including but not limited to, an impact pertaining to Environmental Justice.

Under NYSDEC Policy CP-29, Waste Management of New York will provide stakeholders with information about the proposed permit modification and permit review process. A public information meeting has been scheduled at which you can get information about this project, speak with WM representatives, learn more about the permitting process, discuss your concerns and submit written or verbal comments.

### Reuniones de información pública para Waste Management of New York, LLC Estación de transferencia de residuos sólidos de Review Avenue Solicitud de modificación del Permiso de la Parte 360

Waste Management of New York, LLC (WM) ha presentado una solicitud al Departamento de Conservación Ambiental del Estado de Nueva York (NYSDEC) para modificar el Permiso de la Parte 360 para operar una estación de transferencia de residuos sólidos situada en 38-22 Review Avenue en Long Island City. WM propone reemplazar la operación actual de transferencia con camiones de Review Avenue por un nuevo establecimiento de transferencia de residuos sólidos por vía ferroviaria, que recibiría los residuos residenciales de Western Queens, según un contrato a largo plazo celebrado con el Departamento de Servicios Sanitarios de la Ciudad de Nueva York (DSNY). Dentro del establecimiento totalmente cerrado, los camiones de recolección de DSNY volcarán los residuos que luego se colocarán en contenedores intermodales. Esos contenedores luego se sellarán y transferirán por camión al depósito ferroviario Maspeth Railyard para su envío por ferrocarril a los lugares de eliminación fuera de la Ciudad. Para implementar este plan, WM solicita aumentar la capacidad autorizada del establecimiento de transferencia de residuos sólidos de Review Avenue de 958 toneladas por día a 2,100 toneladas por día.

El NYSDEC está analizando que la propuesta cumpla con la norma que rige los Establecimientos Estatales de Manejo de Residuos Sólidos (6 NYCRR Parte 360) y determinará si, de conformidad con la norma de Revisión de Calidad Ambiental del Estado (6 NYCRR Parte 617), la propuesta daría como resultado un impacto adverso posible y considerable incluido, entre otros, el impacto relacionado con la Justicia Ambiental.

Según la Norma CP-29 del NYSDEC, Waste Management of New York proporcionará a todas las partes interesadas información sobre la modificación propuesta del permiso y sobre el proceso de revisión del permiso. Una reunión de información pública se ha programado en el que usted puede obtener información sobre este proyecto, hablar con representantes de WM, enterarse sobre el proceso de obtención de permisos, hablar de sus inquietudes y presentar comentarios escritos o verbales.

## Municipal Bonds Offer Tax Benefits

If you're an investor, 2003 was a pretty good year, from a tax standpoint. The new tax laws lowered tax brackets and cut the maximum rates on long-term capital gains and stock dividends to 15 percent. Still, for 2004, you may want to do even more to control your investment taxes—so you might want to consider municipal bonds.

By investing in municipal bonds, or "munis," you may be able to achieve significant advantages, particularly if you're in one of the upper tax brackets. When you own a muni, your interest payments will be free from federal taxes, and, if the municipality that issues the bond is located in your state, your interest payments also may be exempt from state and local taxes.

In fact, the tax advantage of municipal bonds may be so great that you'd have to earn a considerably higher interest rate on a taxable bond—such as a corporate bond—just to get the same after-tax return. For example,

suppose your tax bracket is 25 percent, your state income tax rate is 5 percent and you buy a state tax-free municipal bond that pays 4.5 percent interest. You would have to earn 6.32 percent, or higher, on a corporate bond of similar maturity and quality to match the 4.5 percent yield of your muni. This 6.32 percent figure is the municipal bond's "taxable equivalent yield." And your municipal bond would provide you with an even greater taxable equivalent yield if you were in a higher tax bracket.

### MUNIS AND THE AMT

Municipal bond interest is free from federal taxes, but some munis—particularly airport and housing bonds—might be subject to the alternative minimum tax (AMT). If you think you may have to pay the AMT, you might want to avoid these types of bonds. Conversely, if you know you won't be assessed the AMT even if you bought some AMT-subject munis, you might be especially

interested in these bonds, because their yields are typically higher than the yields on regular munis.

### OTHER BENEFITS OF MUNIS

Municipal bonds are issued in two main categories: general obligation bonds and revenue bonds. General obligation bonds finance the ongoing activities of state and local governments, while revenue bonds pay for specific projects, such as airports, hospitals and other civic institutions.

So, when you invest in munis, you'll get more than tax advantages—you'll also get the satisfaction of supporting valuable projects or services in your own state or community.

And that's not all. Consider two other benefits you may get from investing in municipal bonds:

**Diversification**—By purchasing municipal bonds, you can help diversify an equity-heavy portfolio. Municipal bond prices generally do not move together with stock prices. And if you hold your municipal bonds until maturity, you can ex-

This type of portfolio—known as a bond "ladder"—can help you in all types of interest-rate environments. When market rates are down, you'll have your long-term bonds locking in higher yields. But when market rates are up, you'll have the proceeds of your short-term bonds available to reinvest.

**Spots May Indicate Problem**

If you see spots in your field of vision occasionally, this may just be a temporary and harmless condition that soon fades away. However, there are certain eye conditions in which spots indicate a serious problem may be developing and should be treated promptly. Only a thorough eye examination can determine this.

For instance, one vision problem associated with eye spots is ocular histoplasmosis syndrome or OHS. According to the National Institute of Health, this is a potentially blinding condition that attacks the part of the eye responsible for sharp, straight-ahead vision used in reading and driving. OHS is a late-developing complication of a common airborne disease called histoplasmosis. One source of this disease is breathing dust from buildings that contain bird, chicken, or bat droppings.

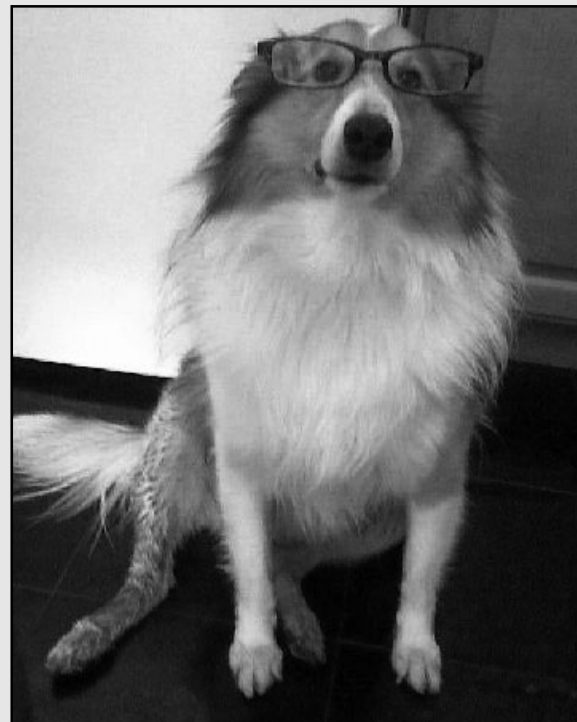
Whatever may be causing the spots in your eyes, you should have your eyes examined by your eye doctor.

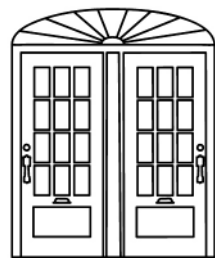
