STANDING UP TO TRAFFIC AGENTS CAN GET YOU ARRESTED IN SUNNYSIDE!

On Tuesday morning at approximately 9:30 A.M. on August 11, 2009, one of our well-known community Doctors arrived in front of his office in Sunnyside. Little did he know that an hour later he would be

arrested, handcuffed and brought to the 108th police precinct! After this humiliation, as his patients and neighbors watched on 46th street, he was taken away, fingerprinted, a mug shot taken and he was placed in a 6' X 8' ft

cell, and processed through the system like a dangerous criminal.

Dr. David Goldhaber has been a pillar of the community for 28 years, as well as a devoted friend. He is a member of the Chamber of Commerce and a Kiwanian for over 25 years. He has contributed to our neighborhood and the well being of our residents since 1980.

This ridiculous scene of events began as Dr. Goldhaber drove up to his office at 43-15 46th Street. Midway up the block an access-a-ride car was discharging two of the Doctors handicapped patients. The Doctor pulled up directly behind the car and discharged his passenger to unlock the office door for the waiting seniors to get out of the hot August heat. As the Doctor was parked behind the access-aride car he observed a man who was going to move his car from a parking spot directly in front of the Doctor's office. The Doctor then drove his car in front of the access-a-ride car to wait for the impending spot. As he opened his door to retrieve his cell phone, which had fallen between the seat and car door, a blue traffic vehicle sped forward in front of the Doctor's car. Two traffic agents jumped out of the car like a swat team and shouted "you're getting a ticket for double parking!" The Doctor, who was dressed in his scrubs, looked at them and responded with "Are you joking? I'm not double parked, I've

just pulled in front of my office to get this parking spot." Traffic Agent Smith, with the scanner in her hand, said again "You're getting a ticket for double parking; we saw you pull up behind that car (access-a-ride) and then you pulled in front of it." Dr. Goldhaber responded that he was not double-parked and would not accept their harassment or intimidation tactics.

He immediately requested that they radio their supervisor to the scene, so that he and the other witnesses could verify his claim against their altercation. After repeatedly refusing to radio for a supervisor and turning their backs on him, Dr. Goldhaber decided that they should not leave the scene and get away with an IN-VENTED ticket. He would have to call for police assistance himself. He then told the two agents "You are not leaving the scene until this is resolved honestly". He walked over to their vehicle and sat on the hood of Blue Traffic Car and dialed 911. After 2 attempts on his cell phone, he had to call his office and have them call for 911 assistance.

As Dr. Goldhaber sat on the hood of the car, the two agents still had not radioed for their supervisor. According to the Doctor the second Traffic Agent Harrigan, who was sitting behind the driver's seat this time, began to put her foot on the accelerator and "rev" the engine repeatedly. This was to heat up the car hood until it was burning hot, even as the August heat measured 82 degrees that morning. The agents laughed as the Doctor lifted himself up and down to prevent any serious burns to his

About 10 minutes after the 911 call, the first of three patrol cars arrived on the scene, followed 10 minutes later by a patrol van with Sergeant Faini from the 108th precinct. Traffic Supervisor TSI Kuruvilla did not arrive on the scene until 15 minutes later, which was approximately 45 minutes after this entire episode began.

Police Sergeant Faini spoke

to his officers who were at the scene, in addition to Dr. Goldhaber, the two agents, their supervisor and the Doctor's employees also at the scene. Traffic Supervisor Kuruvilla only spoke to his Traffic Agents Smith and Harrigan and in no way approached Dr. Goldhaber or any of the witnesses to get their account as to what had transpired.

It was nearing 11:00 A.M. when the Doctor asked the sergeant if he could go inside his office to where 5 patients were now waiting. The sergeant responded to Dr. Goldhaber that he could not leave because he was being arrested! In bewilderment, the Doctor told Sergeant Faini "I don't understand this; I was wrongfully ambushed by these traffic agents." I responded to them peacefully by requesting that a supervisor come and talk with me along with the witnesses and was totally ignored by Traffic Agents Smith and Harrigan. They were trying to leave with the issuing of a groundless "bogus" double-parking ticket. The Doctor told the sergeant that <u>his</u> office called for help, not the traffic agents. The sergeant explained that there is now a law, which states that if someone prevents a government employee from performing his or her job they are to be arrested for obstruction. He said the agents told him that the driver prevented them from giving him a ticket. The sergeant said to Dr. Goldhaber that he understands the whole situation, but he had no choice but arrest him under the law. The Doctor went willingly, as he was handcuffed and put into the patrol van and taken to the 108th Precinct for processing. He has been scheduled to appear for these charges on Dec.

While Dr. Goldhaber was in his cell, numerous officers heard what he was arrested for. According to the Doctor the whole precinct is aware of what is going on with the T401 Unit Traffic Division.

MAYOR'S CORNER

Getting Our New School Year Off on the Right Foot

In just two weeks, our public school students will be going back to class. We've got every reason to believe that they'll pick up right where they left off last school year – a year when across the city, elementary and middle school students at every grade level continued to make impressive gains, as measured by

the State's standardized tests, in the reading and math skills that are the foundations of learning.



That progress results directly from our decision to steadily eliminate so-called "social promotion" in our schools. Frankly, I can't think of a meaner, more harmful thing to do than to move students up a grade if they're not prepared to take on the work required of them there. That just sets youngsters up for disappointment and failure.

So since 2004, we've done away with social promotion in the 3rd, 5th, 7th, and 8th grades. If students in those grades have trouble meeting the standards they should in reading and math, we now give them intensive remedial help in summer school, and then let them take the tests again. The result is that over the years, the number of students needing to repeat a grade has declined dramatically. In 2004, for example, more than 3,000 3rd graders were held back because of low test scores; in 2008, fewer than 870 were. The same pattern has held in the other grades, too. And the resulting year-by-year climb in reading and math test scores in schools across the city speaks for itself. It's a big reason why President Obama and U.S. Education Secretary Arne Duncan have hailed New York City as an example for bigcity school systems nationwide.

Earlier this month, the Governor and State Legislature also cast a major vote of confidence in our efforts to improve the City's public schools by overwhelmingly reauthorizing the 2002 law that established mayoral responsibility for running the schools. We're grateful for their actions – and we're not going to waste any time in building on the progress we've made. The re-authorized school governance law reestablishes the Panel for Educational Policy, which oversees major decisions by the City's Department of Education. And now the first order of business that we'll ask the Panel to take up is ending social promotion in the 4th and 6th grades, too.

By doing that, they will finally and thoroughly eliminate a cynical and now completely discredited practice in our schools. It will mean that in every grade, in every elementary and middle school, we'll finally be doing things in the right order: Educating our students before we promote them, instead of the other, and wrong, way around. I can't think of a better way to help our students, and get the new school year off on the right foot.



STANDING UP TO TRAFFIC AGENTS **CAN GET YOU ARRESTED** IN SUNNYSIDE!

The Precinct constantly receives complaints about the agents. The words used to describe the traffic agents are unprintable! One officer commented, "Ever since they put them in blue uniforms, they continually give us a bad name. We can legitimately give out 30 summonses for real violations while on tour."

When Dr. Goldhaber was released after being processed, various sources explained which agencies were available to him, if he wished to file a complaint of official misconduct. He has decided to do so because these agents arrested him on false accusations. He was told that he was arrested for obstructing the agent's ability to write a ticket. Yet Dr. Goldhaber was given a ticket. The ticket was written with all the car information and dated 8/11/09 at 9:39 A.M. He had just discharged his passenger and was in his car at the time. The ticket says "No discharging/receiving passengers and No driver. It is signed by Traffic Agent Smith. Is this a case of perjury and official misconduct by a public servant?

The events that happened to Dr. Goldhaber on Aug. 11, 2009 should really hit home to our citizens, neighbors and residents of Sunnyside and western Queens. Over the past 3-4 years we have all witnessed the increased aggressive enforcement that has taken place in our community. With the advent of these scanners, the traffic department not only has found a way to increase revenue and allow their agents to achieve their quotas quicker and easier, but many times without reasonable cause. We have all seen cars ticketed while a driver was in their car waiting for a parking spot on Queens Blvd. at 9:59 A.M. while waiting at a meter, for a 10:00 A.M. parking.

It is now our responsibility in the Sunnyside Community to stand up and tell our stories to prevent further abuses. How can we have faith in a system that is spinning out of control? Now is the time to stop this abuse of authority and humiliation in our streets. We should not be afraid to pull our cars in front of our homes or offices, or the discharging of passengers with packages. These agents drive cars with logos of C.P.R. Our community of citizens and neighbors would like to be treated with Courtesy, Professionalism and Respect, but many times are not. Due to the lack of "C.P.R." by some members of the T401 Traffic Unit, we are now living on Mean Streets. Do we not have a voice anymore? Anyone of us could have been a victim of this misconduct by the agent's actions, and then treated like a common criminal, as Dr. Goldhaber was.

Our Community's concerns will be discussed at the Sunnyside Chamber of Commerce meeting on September 8, 2009. We would like our Sunnyside Citizens and businesses to participate and share their stories and experiences that they WoodsideHerald.com may have had with aggressive or abusive traffic agents.
